Nate Cain Announces Candidacy For United States Congress

FBI Whistleblower & Military Veteran Stands For America First Principles & the People of West Virginia

Martinsburg, WV – March 7, 2023 – Nate Cain, a Republican, U.S. Army Veteran, cybersecurity entrepreneur, and FBI whistleblower announces his candidacy for West Virginia’s 2nd Congressional District. With a track record of integrity, selfless service, personal courage, and loyalty to his country, Cain is focused on restoring our Constitutional freedoms, strengthening our national security, and opening the doors to prosperity for all Americans.

Unlike other candidates running in the district that are part of political dynasties or are beholden to special interest groups not serving the interests of West Virginians, Cain seeks to represent everyday Americans who work hard daily to live their lives in pursuit of the American dream.

“I am excited to announce my candidacy for the West Virginia’s 2nd Congressional District,” Cain said. “I believe West Virginia needs a strong and trustworthy leader representing them, with a track record of integrity when it matters. I strongly support the U.S. Constitution and its protection of every American’s God-given rights.”

“Those rights have been under assault by a tyrannical government. It prohibited the free exercise of religion when it shut down churches during covid. It abridged the freedom of speech and of the press when it colluded with the main street media and big tech social media to silence conservatives. It has interfered with the right of people to peaceably assemble and petition the government for a redress of grievances, as they did on January 6th. It has infringed on the people to keep and bear arms through ATF rules and red flag laws. It has violated our right to privacy through unwarranted searches by proxy of big tech, secret courts, and foreign intelligence services. It has deprived its citizens of life, liberty, and property without due process, denying those arrested from January 6th the right to a speedy trial by an impartial jury and by denying bail and thus, putting the burden of proof on the innocent. It has violated the most sacred right of bodily autonomy by forced vaccinations and coercion to participate in medical experiments. It has violated the rights of parents to protect their children from sexualization by deviants, groomers, and pedophiles, thus working to destroy the very fabric of the family unit. These violations of God-given rights are an affront to freedom, liberty, and justice and those that are perpetrating them must be held accountable for being the biggest domestic threat to our Nation.

Our government is charged with providing for the nation’s security and defense against foreign adversaries. And yet, it has weakened the defenses of our nation against our foreign enemies by depleting our military resources, stocks of military weapons and ammunition, and our national strategic reserve. It has weakened our soldiers, sailors, Marines, and airmen with indoctrination of diversity, equity, and inclusion of woke ideologies that have no place in our military armed forces. It has abdicated its responsibility for securing our borders against an invasion of illegal aliens, who are poisoning our youth with fentanyl and other illicit drugs, human trafficking, diseases, and further strains on our public safety nets. It has allowed our enemies to become emboldened by

inaction at increasing breaches of our airspace and territorial waterways. It has given our enemies access to biological agents funding research for their weaponization to be used against us. These violations of our rights and the public trust are an indictment against the current administration. It is the duty of every patriot to stand up and resist such evil. For as Edmond Burke said, ‘All that is required for evil to triumph, is for good men to do nothing,’” Cain proclaims.

Cain states that “as a military veteran, I have taken the oath three times to support and defend The Constitution of the United States against all enemies foreign and domestic. The first time I took the oath was as a US Army soldier and then again as a Navy and Marine civil servant. I delivered on that oath in 2017, when I blew the whistle on the FBI’s coverup of Hillary Clinton’s pay-to-play scheme to sell out U.S. national security.”

Cain is highly regarded for his courage to stand up against the most powerful and corrupt elites in this country. He bravely blew the whistle on Hillary Clinton and the Clinton Foundation while working as a cybersecurity subject matter expert for the FBI. He provided new insights and evidence to the intel committees on Uranium One, Benghazi, and Hillary Clinton’s illegal gun-running in North Africa and the Middle East. Additionally, he was tasked by the White House to assist in providing his expertise in an investigation into election integrity issues after the 2020 debacle. He was an expert witness on election system irregularities in multiple cases, including the multi-state lawsuit against Pennsylvania that was brought before the Supreme Court. Cain now owns and operates [Cain & Associates](#), a cybersecurity company and continues to maintain his high-level national security clearances.

“As an entrepreneur and member of our community in West Virginia, I have seen firsthand the challenges to small business owners striving for the American dream,” Cain said. His roots are found in the coal mines of the Appalachians and American patriots serving in every war since its’ inception. He is a self-made man from humble beginnings having overcome many of the challenges common to families in our district. I want hard-working Americans and future generations to have the opportunity for prosperity and the American dream that was passed down to us. I am committed to working tirelessly to this end.”

“I believe that we need those who are willing to put the interest of the people first, who stand for the truth, call out corruption no matter the cost, and believe in the virtue of hard work,” Cain expressed. “I’m running for office because I love this country and I love West Virginia. I believe there is a difference between being a politician and a representative. A politician serves himself to further his career, a representative serves the people, in hopes of bettering the future for those he represents, I choose to be the latter and I am asking the people of West Virginia to put their trust in me to represent them.”

“As I have traveled around the district, I have spoken to many people, and I believe that I am hearing the issues that are at the heart of West Virginians. I have a plan for a greater West Virginia, one that harnesses our vast natural resources to build an industrial base on energy independence and the development of refineries. This would give us a supply chain that we control, freeing us from dependency on others, while creating secure high paying jobs for the district. I will bring ideas to the table, such as, developing a West Virginia strategic energy reserve under state sovereignty that presidents like Biden cannot deplete. This will give West Virginians a buffer against energy market manipulation. I also recognize the importance of individual mineral rights and their ability to change the lives of many who have been taken advantage of by big corporations and their lawyers. Our citizens need protections and education so that they can build generational wealth. Additionally, the mountain state needs help in modernizing its infrastructure to include increasing availability of broadband internet, which is a necessity for competing in this modern age, and fixing our roads, bridges, and railways. Finally, it is important to protect our farm, cattle, and poultry industries against the encroachment of federal regulations and carbon taxes that have no place in West Virginia. I will be diligent to listen to the needs of all West Virginians,” declares Cain.

Cain humbly recognizes that there is only so much that man can do. He is only one vote in 435 in Congress and therefore cannot promise to do more than be true to his vote and advocate for his principles in his campaign as a representative for West Virginia, but he has faith in something greater than man, he recognizes the principle of divine providence. When he said, “I recognize that unless the Lord builds a house, the laborers build in vain.

That unless the Lord defends the city, the watchmen stand guard in vain. We must put in our effort, plant the seed, and water it, but it is the Lord that makes it grow.” Nate will always acknowledge that in order for West Virginia to succeed, it must have the blessings of God.
